<b>RATINGS</b>	PHRF Ratings as assigned by PHRF of Long Island Sound. Attach <b>2008</b> copy of PHRF certificate. Time-on-Time handicapping will be used.
<b>CLASSES</b>	The Regatta is open to all racing and cruising handicap yachts and to certain one-design classes of at least 5 entrants. Entries will be accepted and assigned to classes at the discretion of the Race Committee. A Non-Spinnaker Class will be included.
<b>COURSE</b>	As selected and posted by the Race Committee. 1 race is planned.
<b>ENTRY FEE</b>	\$25.00 per yacht (\$30.00 for non-US Sailing-member skippers) and \$10.00 per prepaid shore party ticket; \$12.00 at the door.

<b>TROPHIES</b>	1st, 2nd, 3rd for each class with at least 7 entrants.
